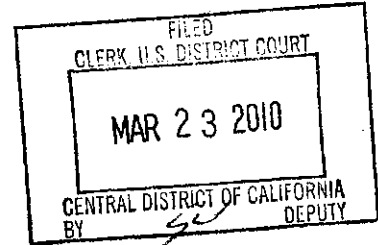

1 The matter having come before the Court on March 22, 2009, and having  
2 considered all papers submitted in connection herewith, and good cause appearing  
3 therefore:

4 **IT IS HEREBY ORDERED THAT** Plaintiff DIRECTV, Inc.'s  
5 ("DIRECTV") Application for a Temporary Restraining Order and Order to Show  
6 Cause re Preliminary Injunction is GRANTED.

7 **ORDER TO SHOW CAUSE**

8 **IT IS HEREBY ORDERED THAT** Defendant Gems TV (USA)  
9 Limited ("GemsTV") appear before the above-entitled Court on  
10 April 1, 2010, at 10:00 a.m., then and there to show cause, if any it  
11 has, why GemsTV, together with its officers, agents, employees, representatives and  
12 those in active participation with it, including affiliates and parent companies, should  
13 not, during the pendency of this action, be enjoined and restrained from engaging in or  
14 performing, directly or indirectly, any or all of the following acts:

15 From transferring, disposing of, parting with, encumbering or  
16 paying or providing to any party, including any parent or affiliate,  
17 any assets to the extent such action will leave GemsTV with less  
18 than \$25 million in actual money or assets.

19 **BRIEFING SCHEDULE**

20 This Order to Show Cause and all moving papers submitted by  
21 DIRECTV in support thereof shall be promptly served by DIRECTV on defendant.  
22 Any response or opposition to the Order to Show Cause must be filed in ~~Department~~  
23 ~~of this Court~~ and personally served or served by e-mail on counsel of record for  
24 DIRECTV no later than March 26, 2010. ~~Proof of service of the~~  
25 ~~response or opposition must be filed with this Court no later than~~  
26 ~~2010.~~

1 Any reply briefing by DIRECTV shall be filed in Department \_\_\_\_\_ of this  
2 Court and personally served or served by e-mail on GemsTV's counsel (if any) no  
3 later than March 30, 2010. ~~Proof of service of the reply shall be filed~~  
4 ~~with this Court on or before \_\_\_\_\_, 2010.~~

5 *DIRECTV is ordered to post a \$10 million bond*  
6 *within seventy-two (72) hours of the issuance of this order.*

**TEMPORARY RESTRAINING ORDER**

7 **PENDING HEARING** on the above Order to Show Cause, GemsTV,  
8 together with its officers, agents, employees, representatives and those in active  
9 participation with any of it, including affiliates and parent companies **ARE HEREBY**  
10 **ENJOINED AND ORDERED TO REFRAIN FROM:**

11 Transferring, disposing of, parting with, encumbering or paying or  
12 providing to any party, including any parent or affiliate, any assets  
13 to the extent such action will leave GemsTV with less than \$25  
14 million in actual money or assets.

15 This Order shall remain in effect ~~until \_\_\_\_\_, 2010~~ [until  
16 DIRECTV's application for a preliminary injunction is resolved].


